"RESOLVES, To enact the following Appropriation Ordinance:


APPROPRIATION ORDINANCE NO. 7

Section 1. The item Contract of Services (Medical Officer III) under Maintenance and Other Operating Expenses of the Mabinay Medicare Community Hospital under Section 2 of Sangguniang Panlalawigan Resolution No. 755, series of 2013, enacting Appropriation Ordinance No. 36 is hereby amended to *Contract of Services (Part-Time Medical Officer III)*.
