"Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated September 23, 2014, forwarding Resolution No. 94, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item Other Expenses-Job Order under the current budget of the Office of the Provincial Treasurer in the amount of ₱60,000.00 to be taken from the allocation of other MOOE items under the same office;

"Funds having been certified as available by the Provincial Accountant per his certification dated September 3, 2014;

"On motion of Honorable Member Georgita F. Martinez, seconded by Honorable Member Peve O. Ligan, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 38  
(Series of 2014)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Other Expenses-Job Order under the current budget of the Office of the Provincial Treasurer in the amount of ₱60,000.00 to cover the payment of Job Orders until December 31, 2014 to be taken from the following items:


Repairs & Maintenance – Office Equipment	₱ 30,000.00
Repairs & Maintenance – IT Equipment and Software	20,000.00
Repairs & Maintenance – Motor Vehicles	10,000.00


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2014.
