“Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated November 20, 2014, forwarding Resolution No. 129, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item Electricity Expenses under the current budget of the Office of the Provincial Social Welfare and Development Officer in the amount of ₱90,000.00 to be taken from the allocation of other MOOE items under the same office;

“Funds having been certified as available by the Provincial Accountant per his certification dated November 14, 2014;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Liland Zoila B. Estacion, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 57
(Series of 2014)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Electricity Expenses under the current budget of the Office of the Provincial Social Welfare and Development Officer in the sum of ₱90,000.00, to be taken from the following items:

Traveling Expenses – Local	₱ 30,000.00
Gasoline, Oil and Lubricants Expenses	32,000.00
Cable, Satellite, Telephone & Radio Expenses	6,000.00
Repairs & Maintenance–Office Equipment	22,000.00
