"Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated December 11, 2014, forwarding Resolution No. 131, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item Food Supplies Expenses under the current Regular budget of Cong. Lamberto L. Macias Memorial Hospital in the amount of ₱20,000.00 to be taken from the allocation of other MOOE items under the same budget;

"Funds having been certified as available by the Provincial Accountant per his certification dated November 10, 2014;

"On motion of Honorable Member Georgita F. Martinez, seconded by Honorable Member Erwin Michael L. Macias, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 61
(Series of 2014)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Food Supplies Expenses under the current Regular Budget of Cong. Lamberto L. Macias Memorial Hospital in the amount of ₱20,000.00, to be taken from the following items:

Traveling Expenses - Local	₱ 5,000.00
Repairs and Maintenance - Hospitals and Health Centers	15,000.00
