“Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated December 16, 2014, forwarding Resolution No. 134-A, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item Traveling Expenses – Local under the current Regular budget of the Bindoy District Hospital in the amount of ₱17,500.00 to be taken from item Accountable Forms Expenses.

“On motion of Honorable Member Erwin Michael L. Macias, seconded by Honorable Member Liland Zoila B. Estacion, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 64
(Series of 2014)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Traveling Expenses – Local under the current Regular budget of the Bindoy District Hospital in the amount of ₱17,500.00, to be taken from item Accountable Forms Expenses.




