“Whereas, presented for consideration before the August Body was the letter of the Assistant Provincial Administrator, this province, dated December 11, 2015, transmitting Resolution No. 62, current series, of the Local Finance Committee, this province, anent the request of Dr. Chelsa R. Cacaldo, Supervising Physician, Community Primary Hospitals, for the augmentation of funds for items Telephone Expenses-Landline, Repairs & Maintenance-Motor Vehicles & Training Expenses under the current budget of the Community Primary Hospitals Provincewide including Supervisor’s Office, in the amount of ₱4,000.00, ₱10,000.00 & ₱182,521.00, respectively, to be taken from the allocation of other MOOE items under the same hospital;

“Funds having been certified as available by the Provincial Accountant per his certification dated November 5, 2015;

“On motion of Honorable Member Melliemoore M. Saycon, seconded by Honorable Member Georgita F. Martinez, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 42

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for various MOOE items under the current budget of the Community Primary Hospitals Provincewide including Supervisor’s Office, in the sum of ₱196,521.00, viz:


