“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 25
(Series of 2016)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱300,000.00 representing existing unobligated allotment balance of the allocation for the Installation/Maintenance of Street Lights, Sitio Tibabay-an, Barangay Lucay, Manjuyod, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated to fund the Road Improvement Program, same barangay.



