"Whereas, presented for consideration before the August Body was the letter of the Assistant Provincial Administrator, this province, dated December 8, 2016, transmitting Resolution No. 26, current series, of the Local Finance Committee, this province, anent the request of Ms. Phoebe A. Pamilaga, Officer-In-Charge, Provincial Social Welfare and Development Office, for augmentation of funds in the sum of ₱75,000.00 for items Water Expenses and Electricity Expenses under the current budget of the PSWDO, to be taken from other MOOE items of same budget;

"Funds having been certified as available by the Officer-In-Charge, Provincial Accountant's Office per certification dated December 1, 2016;

"On motion of Honorable Member Nilo D. Sayson, seconded by Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 33
(Series of 2016)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for items Water Expenses and Electricity Expenses under the current budget of the Provincial Social Welfare and Development Office in the amount of ₱25,000.00 and ₱50,000.00, respectively, to be taken from other MOOE items under the same budget, to wit:

Traveling Expenses – Local	₱25,000.00
Gasoline, Oil and Lubricants Expenses	50,000.00


