“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱160,000.00 representing existing allotment balance of the allocation for Scholarship for Poor but Deserving Students 1st and 2nd Semester (NORSU) is hereby appropriated for the following:

Waterworks Projects (Purchase of P.E.Pipes)
for Barangay Basak, Zamboanguita.....₱60,000.00

Waterworks Projects (Purchase of Jetmatic Pumps) for Barangay Nagbo-alao, Basay.....	₱30,000.00
Assistance to Individuals in Crisis Situation.....	70,000.00

Section 2. The amount of ₱140,000.00 representing existing allotment balance for item Repairs and Maintenance – Transportation Equipment under the Sangguniang Panlalawigan is hereby appropriated for the following:

Purchase of Office Supplies.....	₱50,000.00
Three (3) Job Orders from September to December, 2017.....	90,000.00

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
