"Whereas, presented for consideration before the August Body was the letter of the OIC-Provincial Administrator, this province, dated December 4, 2017, transmitting Resolution No. 50, current series, of the Local Finance Committee, anent the request of Mr. Nestor R. "On motion of Honorable Member Miguel L. Dungog, seconded by Honorable Member Nilo D. Sayson, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Acting Governor is hereby authorized to augment the appropriation for item Water Expenses under the current budget of the Office of the Provincial Agriculturist, in the amount of ₱25,000.00, to be taken from item Electricity Expenses of same office.


