## RESOLUTION NO. 1119

"Whereas, presented for consideration before the August Body was the letter of the OIC-Provincial Administrator dated December 7, 2017, transmitting Resolution No. 50-A, current series, of the Local Finance Committee, this province, anent the request of Ms. Phoebe A. Pamilaga, OIC-Office of the Provincial Social Welfare and Development Officer, this province; and requesting authority for augmentation of funds for item Special Social Services for Senior Citizens and PWDs: Financial Assistance for Medicines, Physical Restoration and other Medical Related Needs under the current budget of the Office of the Provincial Social Welfare and Development Officer, in the amount of \$700,000.00, to be taken from item Special Social Services for Senior Citizens and PWDs: Augmentation of Health Insurance to Indigent PWDs under Other Special Purpose Appropriation - MOOE of same office.

"Funds having been certified as available by the OIC-Provincial Accountant per her certification dated November 17, 2017;

"On motion of Honorable Member Kit Marc B. Adanza, seconded by Honorable Member Ma. Rosario F. Ocay and Honorable Member Nilo D. Sayson, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

## APPROPRIATION ORDINANCE NO. 65 (Series of 2017)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Acting Governor is hereby authorized to augment the appropriation for item Special Social Services for Senior Citizens and PWDs: Financial Assistance for Medicines, Physical Restoration and other Medical Related Needs under the current budget of the Office of the Provincial Social Welfare and Development Officer, in the amount of \$700,000.00, to be taken from item Special Social Services for Senior Citizens and PWDs: Augmentation of Health Insurance to Indigent PWDs under Other Special Purpose Appropriation - MOOE of same office.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2017.
