"On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Nilo D. Sayson, the Sangguniang Panlalawigan

"RESOLVES, To approve Resolution No. 3, current series, of the Provincial Development Council Executive Committee, this province, and Addendum No. 5 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 6  
(Series of 2017)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱300,000.00 representing existing unobligated allotment balance of the allocation for the project Concreting of Calapan Road, Purok San Pedro, Buñao, Dumaguete City is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Covered Drainage Canal, Calapan Road, Barangay Buñao, Dumaguete City.


