“Presented for legislative authorization before the August Body was Supplemental Budget No. 26 of the General Fund - 20% Development Fund for Calendar Year 2017 in the amount of ₱200,000.00 for the Rehabilitation/Improvement of Multipurpose Pavement, Barangay Lamogong, Manjuyod, as embodied under Resolution No. 31, current series, of the Provincial Development Council Executive Committee, with the corresponding Addendum No. 26 of the Annual Investment Program for Calendar Year 2017;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Peve O. Ligan, the Sangguniang Panlalawigan

“RESOLVES, To approve Resolution No. 31, current series, of the Provincial Development Council Executive Committee, this province, and Addendum No. 26 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 26  
(Series of 2017)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱200,000.00 representing existing unobligated allotment balance of the allocation for the project Installation/Maintenance of Street Lights, Sitio Jamlon, Lamogong, Manjuyod, is hereby reverted to the unappropriated balance of the 20% Development Fund.

Section 2. The amount of ₱200,000.00 is hereby appropriated from the unappropriated balance of the 20% Development Fund for the Rehabilitation/Improvement of Multipurpose Pavement, Barangay Lamogong, Manjuyod.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
