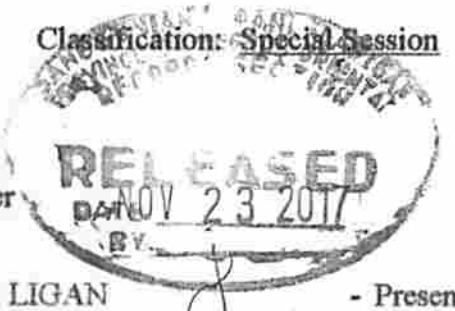

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 35
(Series of 2017)

“Be it enacted by the Sangguniang Panlalawigan that:


Section 1. The amount of ₱1,960,552.90 representing unobligated allotment balance of the allocation for Concreting of Access Road to Resettlement Site, Barangay Sto. Niño, San Jose, Negros Oriental, is hereby reverted to the unappropriated balance of the 20% Development Fund.


Section 2. The amount of ₱1,960,552.90 is hereby appropriated from the unappropriated balance of the 20% Development Fund, for the Improvement of Barangay Basak Road, San Jose, Negros Oriental.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
