“Presented for legislative authorization before the August Body was Supplemental Budget No. 37 of the General Fund - 20% Development Fund for Calendar Year 2017 in the amount of ₱400,000.00 for the Construction of Drainage Canal, Barangay San Antonio, Sibulan, as embodied under Resolution No. 23, current series, of the Provincial Development Council Executive Committee, with the corresponding Addendum No. 37 of the Annual Investment Program for Calendar Year 2017;

“Funds having been certified as available by the Officer-In-Charge, Provincial Accountant’s Office per her certification dated July 28, 2017;

“On motion of Honorable Member Jessica Jane J. Villanueva, seconded by Honorable Member Nilo D. Sayson, the Sangguniang Panlalawigan

“RESOLVES, To approve Resolution No. 23, current series, of the Provincial Development Council Executive Committee and Addendum No. 37 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 39
(Series of 2017)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱400,000.00 representing unobligated allotment balance of the allocation for the Construction of Cross-Drainage, Barangay San Antonio, Sibulan, is hereby reverted to the unappropriated balance of the 20% Development Fund.

Section 2. The amount of ₱400,000.00 is hereby appropriated from the unappropriated balance of the 20% Development Fund, for the Construction of Drainage Canal, Barangay San Antonio, Sibulan.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


