“Be it enacted by the Sangguniang Panlalawigan that:




The amount of ₱616,500.00 representing existing allotment balance of the allocation for Medical, Dental and Laboratory Equipment-30 Hospital Beds at ₱50,000.00 each under the Special Account Budget of the Governor William ‘Billy’ Villegas Memorial Hospital for Calendar Year 2016 is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the Purchase of Twenty (20) units Hospital Bed with Mattress and Bedside Table for the same hospital.


