“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱197,580.00 representing existing allotment balance of the allocation for Office Equipment – 5 Units Airconditioner under the Provincial Agriculturist’s Office is hereby reverted to the unappropriated balance of the General Fund.

Section 2. The amount of ₱197,580.00 is likewise appropriated for the purchase of office equipment for the Provincial Agriculturist’s Office, viz:

1 Unit Photocopier.....	77,000.00


1 Unit LCD Projector.....	₱ 25,000.00
