The amount of \$\phi600,000.00\$ representing existing unobligated allotment balance of the allocation for the Completion of Health Center, Barangay San Isidro, Manjuyod, funded under the current 20% Economic Development Fund is hereby appropriated for the Construction of Multipurpose Center, same barangay.

Section 4. The amount of \$\phi 500,000.00\$ representing existing unobligated allotment balance of the allocation for the Completion of Street Lightings, Barangay North Poblacion, La Libertad, funded under the 20% Economic Development Fund for Calendar Year 2013 is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Construction of Concrete Manholes and Concreting of Barangay Road, same barangay.

Section 5. The amount of \$\phi 100,000.00\$ representing existing unobligated allotment balance of the allocation for the Construction of Multipurpose Hall, Barangay Magtuhao, Bindoy, funded under the current 20% Economic Development Fund is hereby appropriated for the Improvement of Multipurpose Hall in Sitio Mantahaw, Barangay Nalundan, Bindoy.





Section 6. The amount of \$50,000.00 representing existing unobligated allotment balance of the allocation for the Construction of Multipurpose Hall, Barangay Pindahan, Tayasan, funded under the current 20% Economic Development Fund is hereby appropriated for the Improvement of Multipurpose Hall, same barangay.

Section 7. The sum of \$\partial 1,800,000.00\$ representing existing unobligated allotment balance of the allocation of projects funded under the 20% Economic Development Fund for Calendar Year 2012 and 2013, viz:

Section 8. The amount of \$\phi\$1,000,000.00 representing existing unobligated allotment balance of the allocation for the Concreting of Road, Barangay IV (from Engr. Olis to Sitio Maya), Tanjay City, funded under the 20% Economic Development Fund for Calendar Year 2013 is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Improvement of Drainage System of Barangay Poblacion IV, Tanjay City.

Section 9. The amount of \$\psi 1,350,000.00\$ representing existing unobligated allotment balance of the allocation for the Improvement of East Balabag-Balugo Road, Valencia, under the 20% Economic Development Fund for Calendar Year 2013 is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Improvement of Barangay Road along Del Castillo Lot to East Balabag-Balugo Road, same municipality.

Section 10. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
