“Presented for legislative authorization before the August Body was Supplemental Budget No. 22 of the General Fund for Calendar Year 2019 in the amount of ₱6,535,465.04 for various expenditures of the provincial government;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Chester V. Lim, the Sangguniang Panlalawigan, in session duly assembled

“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 40
(Series of 2019)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱6,535,465.04 TO COVER VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱6,500,000.00 representing unexpended allocation for the Payment of Calamity Insurance Premium for Provincial Government-Owned Buildings is hereby reverted to the unappropriated balance of


the General Fund; the same amount is likewise appropriated for the same program to be classified as Maintenance and Other Operating Expense.


Section 2. The amount of ₱35,465.04 representing current Personal Services Savings – Salaries and Wages (Regular) is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover the deficiency in the Payment for Catering Services during the conduct of the Capacity Enhancement Training on the Roles of Barangay Nutrition Scholars During Disasters and Other Emergencies last December 19, 2018.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


