"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Water Expenses under the Regular Budget of the Bindoy District Hospital in the sum of ₱37,500.00 to be taken from the following items:

Training Expenses .....	₱ 20,000.00
Accountable Forms Expenses .....	17,500.00


