APPROPRIATION ORDINANCE NO. 36 (Series of 2015)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for various MOOE items under the current budget of the Office of the Provincial Treasurer to be taken from item Other Financial Charges of same office, in the sum of \$\pi\122,200.00\$, viz:

Subscription Expenses 9 2,200.00 Financial Expenses - Bank Charges 120,000.00

Section 2. The amount of \$2,200.00 and \$120,000.00 shall be solely utilized for the Subscription of Newspaper and Purchase of 20,000 pieces of Customized Checks, respectively, per letter request of the Provincial Treasurer dated November 9, 2015.

Section 3. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2015.
