“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,600,000.00 representing current Personal Services Savings – Salaries and Wages (Regular) of the General Fund is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the Purchase of Vehicle for the Negros Oriental Provincial Health Office.




