“Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated December 16, 2014, forwarding Resolution No. 133-A, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for various MOOE items under the current Hospital Income budget of the Bayawan District Hospital in the sum of ₱327,300.00 to be taken from the allocation of other MOOE items under the same hospital.

“Funds having been certified as available by the Provincial Accountant per his certification dated December 10, 2014;

“On motion of Honorable Member Erwin Michael L. Macias, seconded by Honorable Member Peve O. Ligan, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for various MOOE items under the current Hospital Income budget of the Bayawan District Hospital in the sum of ₱326,955.00, viz:
