



RESOLUTION NO. 848

"Whereas, presented for consideration before the August Body was the letter of the Assistant Provincial Administrator, this province, dated December 15, 2015, transmitting Resolution No. 61, current series, of the Local Finance Committee, this province, anent the request of Dr. Chelsa R. Cacaldo, Supervising Physician, Community Primary Hospitals, for the augmentation of funds for item Training Expenses under the current budget of the Luz-Sikatuna Community Primary Hospital, in the amount of \$\pi19,200.00\$ to be taken from the allocation of other MOOE items under the same hospital;

"Funds having been certified as available by the Provincial Accountant per his certification dated November 5, 2015;

"On motion of Honorable Member Jessica Jane J. Villanueva, seconded by Honorable Member Peve O. Ligan, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 41 (Series of 2015)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Training Expenses under the current budget of the Luz-Sikatuna Community Primary Hospital, in the amount of \$19,200.00 to be taken from the allocation of other MOOE items under the same budget, viz:

Gasoline, Oil & Lubricants Expenses	₱ 5,000.00
Cable, Satellite, Telegraph & Radio Expenses	4,200.00
Insurance Expenses	10,000.00



Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2015.
