"Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated October 28, 2015, forwarding Resolution No. 32, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item 'Traveling Expenses – Local', under the current budget of the Negros Oriental Detention and Rehabilitation Center, in the amount of \$50,000.00, to be taken from item 'Drugs and Medicines Expenses' of same center.

Ligan, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 53 (Series of 2015)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item "Traveling Expenses - Local" under the current budget of the Negros Oriental Detention and Rehabilitation Center, in the amount of \$950,000.00, to be taken from item "Drugs and Medicines Expenses" of same center.

Section 2. The amount of \$50,000.00 shall be solely utilized for the transport of two (2) Insular Prisoners.

Section 3. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2015.
