“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 81
(Series of 2018)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱255,000.00 is hereby reverted to the unappropriated balance of the General Fund representing existing allotment balance of MOOE items under the Office of the Clerk of Court, viz:

Traveling Expenses-Local	₱ 10,000.00
Training Expenses	230,000.00
Repairs & Maint. – Machinery Equipment	15,000.00.







Section 2. The amount of ₱255,000.00 is hereby appropriated for the Purchase of Furniture and Fixtures for the Office of the Clerk of Court, Regional Trial Court of Negros Oriental.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
