"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$\phi\$1,000,000.00 representing unexpended allocation for Road Concreting in Purok II, Barangay Mantuyop, Siaton, under the 20% Development Fund for Calendar Year 2019 is hereby reverted to the unappropriated balance; the same amount is likewise appropriated for the Concreting of Barangay Farm-To-Market Road at Purok III, Barangay Mantuyop, Siaton.
