“On motion of Honorable Member Jose A. Baldado, seconded by Honorable Member Ma. Antonia E. Villegas, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 6
(Series of 2021)

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM POSTAGE AND COURIER SERVICES UNDER THE BUDGET OF THE PROVINCIAL TREASURER’S OFFICE IN THE AMOUNT OF ₱30,000.00.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Postage and Courier Services under the budget of the

Provincial Treasurer's Office in the amount of ₱30,000.00, to be taken from item Printing and Publication Expenses.


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2021.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
