

## APPROPRIATION ORDINANCE NO. 21 (Series of 2021)

AN ORDINANCE APPROPRIATING THE AMOUNT OF \$5,000,000.00 FOR THE CONCRETING OF CASALAAN BARANGAY ROAD, CASALAAN, SIATON, NEGROS ORIENTAL.

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$5,000,000.00 representing unexpended allocation for Various Socio-Economic Development Projects for the



Municipality of Siaton, Negros Oriental, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Concreting of Casalaan Barangay Road, Casalaan, Siaton, Negros Oriental.
