## **RESOLUTION NO. 900**

"Presented for consideration before the August Body was the 2<sup>nd</sup> Indorsement of the Chairman, Local Finance Committee, dated November 25, 2021, transmitting Resolution No. 154, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds in the amount of \$\mathbf{P}\$1,000,000.00 for item Fuel, Oil and Lubricants Expenses under the current budget of the Sangguniang Panlalawigan, to be taken from item Training Expenses, per letter-request of the Honorable Vice Governor;

"Funds having been certified as available by the Provincial Accountant per his certification dated November 25, 2021;

"On motion of Honorable Member Estanislao V. Alviola, seconded by Honorable Member Ma. Antonia E. Villegas, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

## APPROPRIATION ORDINANCE NO. 48 (Series of 2021)

AN ORDINANCE AUTHORIZING THE HONORABLE VICE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM FUEL, OIL AND LUBRICANTS EXPENSES UNDER THE CURRENT BUDGET OF THE SANGGUNIANG PANLALAWIGAN IN THE AMOUNT OF \$\mathbf{p}\$1,000,000.00.



"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Vice Governor is hereby authorized to augment the allocation for item Fuel, Oil and Lubricants Expenses under the current budget of the Sangguniang Panlalawigan in the amount of \$\pi\$1,000,000.00, to be taken from item Training Expenses.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2021.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
