“Presented for consideration before the August Body was the letter of Vice Governor Edward Mark L. Macias, M.D. dated February 17, 2014, requesting that the personnel holding the positions of Private Secretary I and Private Secretary II under his office be exempted from the provisions of Section 24 of Appropriation Ordinance No. 36, series of 2013;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Georgita F. Martinez, the Sangguniang Panlalawigan

“RESOLVES, To grant the request of Vice Governor Edward Mark L. Macias, provided that no additional appropriation will be made for item Telephone Expenses-Mobile;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 1  
(Series of 2014)

Section 1. Section 24 of Sangguniang Panlalawigan Resolution No. 755, series of 2013, enacting Appropriation Ordinance No. 36, is hereby amended to read as follows:

Section 24. Telephone Expenses – Mobile. This account shall be used for purchase of phone/cell cards or mobile plans by Offices for use of Department Heads and other authorized personnel (not lower than Division Chiefs except the positions Private Secretary I and Private Secretary II under the Vice Governor’s Office) but not to exceed ₱18,000.00 a year,


regardless of source of budget. Other Offices that have frequent contacts with their field personnel in the implementation of their programs/projects/activities, including the PDRRM Center where communication is essential during calamities and disasters and Hospitals may be allocated more than ₱18,000.00, but not to exceed ₱28,800.00 a year. Allocations in excess thereof shall be utilized upon authority by the Sangguniang Panlalawigan. All elected officials of the province are not covered by this provision.



Section 2. This Appropriation Ordinance shall take effect January 1, 2014.
