“Presented before the August Body for legislative authorization was Supplemental Budget No. 9 of the General Fund – 20% Economic Development Fund for Calendar Year 2014 in the sum of ₱14,550,780.74 to fund various programs, projects, and activities of the provincial government embodied under Resolution Nos. 15, 16, 17, 18, 20, and 23, all current series, of the Provincial Development Council Executive Committee, with the corresponding Addendum No. 8 of the Annual Investment Program for Calendar Year 2014;

“On motion of Honorable Member Liland Zoila B. Estacion, seconded by Honorable Member Ma. Antonia E. Villegas, the Sangguniang Panlalawigan

“RESOLVES, To approve Resolution Nos. 15, 16, 17, 18, 20, and 23, all current series, of the Provincial Development Council Executive Committee and Addendum No. 8 of the Annual Investment Program for Calendar Year 2014, subject to the usual accounting and auditing rules, regulations and policies, except Cattle Fattening Project to be Undertaken by an NGO/PO under Reference Code 8000-6-18;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

**APPROPRIATION ORDINANCE NO. 12**  
**(Series of 2014)**

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱619,465.00 representing existing unobligated allotment balance of the allocation for the Improvement of Multipurpose Pavement in Barangay Tapon Norte, San Jose, under the current budget is hereby appropriated for the Improvement of Multipurpose Building in same barangay.

Section 2. The amount of ₱1,019,465.00 representing existing unobligated allotment balance of the allocation for the Construction of Multipurpose Building/Evacuation Center, Barangay Tambojangan, Amlan, under the current budget is hereby appropriated for the Construction of Multipurpose Hall/Evacuation Center adjacent to the Municipal Building, Amlan.

Section 3. The sum of ₱1,535,155.85 representing Accounts Payable under SL Account Nos. 3-8918-072(12)-12-4399-12, 3-8918-109(12)-12-4397-12, and 3-8918-107(12)-12-4402-12 is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the following:

Road Opening for So. Pag-awitan (Purchase of Fuel), Bayawan City .....	₱ 149,987.25
Rehabilitation of Bugay-Lapay Road (Purchase of Fuel), Bayawan City .....	693,991.60

Section 4. The amount of ₱500,000.00 representing existing unobligated allotment balance of the allocation for the Construction of Multipurpose Building, Barangay Bifohon, Bais City, under the current budget is hereby appropriated for the Improvement of Waterworks System in same barangay.

Section 5. The amount of ₱300,000.00 representing existing unobligated allotment balance for the Purchase/Repair of Calamity Related Rescue Operation Equipment under the current budget (allocation of Honorable Ma. Antonia E. Villegas), is hereby appropriated for the Purchase of Calamity Related Rescue Operation Equipment.

Section 6. The amount of ₱10,576,694.89 is hereby appropriated from the surplus of the 20% Economic Development Fund for Calendar Year 2013, to fund the following projects:


