AN ORDINANCE AMENDING SECTION 1 OF TAX ORDINANCE NO. 9, SERIES OF 2012, BY EXTENDING THE DURATION OF THE COMPROMISE AGREEMENT ON THE PAYMENT OF REAL PROPERTY TAXES FOR ANOTHER TWO (2) YEARS STARTING JANUARY 1, 2014.

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. Section 1 of Tax Ordinance No. 9, series of 2012, is hereby amended by extending the duration of the Compromise Agreement on the payment of real property taxes for another two (2) years starting January 1, 2014 to December 31, 2015.
