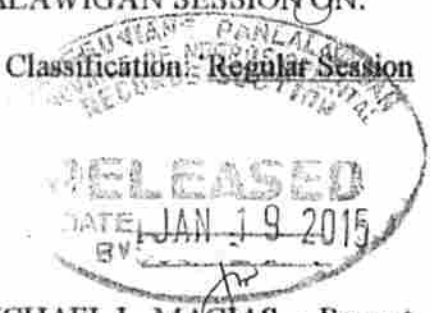

RESOLUTION NO. 918

"Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated November 28, 2014, forwarding Resolution No. 126, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for various MOOE items under the current budget of the Community Primary Hospitals (Supervisor's Office) in the amount of ₱670,000.00 to be taken from item Contract of Services;

"Funds having been certified as available by the Provincial Accountant per his certification dated November 14, 2014;

On motion of Honorable Member Liland Zoila B. Estacion, seconded by Honorable Member Ma. Antonia E. Villegas and Honorable Member Chester V. Lim, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 58
(Series of 2014)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation of various MOOE items under the current budget of the Community Primary Hospitals (Supervisor's Office), viz:

Drugs & Medicines Expenses.....	₱ 350,000.00
Medical, Dental & Laboratory Supplies Expenses.....	210,000.00
Training Expenses.....	60,000.00
Traveling Expenses - Local.....	50,000.00

to be taken from item Contract of Services under the same budget.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2014.
