"Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated December 11, 2014, forwarding Resolution No. 129-A, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for various Personal Services items under the current Regular Budget of the Bindoy District Hospital in the amount of ₱223,081.75 to be taken from item Salaries & Wages – Regular Pay;

"Funds having been certified as available by the Provincial Accountant per his certification dated December 5, 2014;

"On motion of Honorable Member Peve O. Ligan, seconded by Honorable Member Georgita F. Martinez, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 62
(Series of 2014)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation of various Personal Services items under the current Regular Budget of the Bindoy District Hospital, viz:

Overtime and Night Pay.....	₱ 168,729.75
Health Workers Benefits – Hazard Pay Allowance.....	44,352.00
Loyalty Award Bonus.....	10,000.00

to be taken from item Salaries and Wages – Regular Pay under the same budget.
