"Be it enacted by the Sangguniang Panlalawigan that:



Section 1. The amount of ₱28,000,000.00 is hereby appropriated from the current Personal Services savings of the General Fund including devolved Hospitals for the grant of Productivity Enhancement Incentive (PEI) to employees of the provincial government, pursuant to Executive Order No. 181 dated May 15, 2015.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
