“On motion of Honorable Member Peve O. Ligan, seconded by Honorable Member Clayborne Clyde L. Lim, the Sangguniang Panlalawigan

“RESOLVES, To approve Addendum Nos. 1 and 2 of the Annual Investment Program for Calendar Year 2015, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 7  
(Series of 2015)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱300,000.00 representing existing unobligated allotment balance of the allocation for the Purchase/Repair of Appropriate Calamity-Related Operations Equipment (BM Chester V. Lim), is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same

amount is likewise appropriated for the Purchase of Chainsaw for the following LGU Beneficiaries:

Section 2. The amount of ₱500,000.00 representing existing unobligated allotment balance of the allocation for the Construction of two (2) units Multipurpose Hall (BM Chester V. Lim), is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Construction of one (1) unit Multipurpose Hall, Barangay Bangkal, Jimalalud, Negros Oriental.

Section 3. The amount of ₱300,000.00 representing existing unobligated allotment balance of the allocation for the Improvement of Waterworks System, Barangay Pantao, Mabinay, is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Rehabilitation of Farm-to-Market Road, Barangay Pantao, Mabinay.

Section 4. The amount of ₱350,000.00 representing existing unobligated allotment balance of the allocation for the Improvement of Campayo to Tangtang Barangay Road, Olandao, Basay, is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Improvement of Campayo to Tangtang Barangay Road, Cabatuanan, Basay.

Section 5. The amount of ₱130,000.00 representing existing unobligated allotment balance of the allocation for the Improvement of Road in Sitio Yardahan, Barangay Poblacion, Basay, is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Improvement of Drainage Canal along Purok 5 Area of Poblacion, Basay.

Section 6. The amount of ₱4,065,000.00 representing existing unobligated allotment balance of the allocation for the Construction/Improvement of Road, Poblacion to Bal-os, Basay, is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Improvement of Roads, Poblacion, Basay.

Section 7. The amount of ₱350,000.00 representing existing unobligated allotment balance of the allocation for the Construction of Multipurpose Pavement (MPP), Sitio Pulang Yuta, Kalamtukan, Bayawan City, is hereby reverted to the unappropriated balance of the 20% Economic Development Fund;

the same amount is likewise appropriated for the Construction of Multipurpose Pavement (MPP), Sitio Cogon, Barangay Kalamtukan, Bayawan City.

Section 8. The amount of ₱100,000.00 representing existing unobligated allotment balance of the allocation for the Improvement/Refurbishment of Multipurpose Building, Barangay Poblacion, Guihulngan, is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Purchase of Vehicle for Emergency Rescue Operations.

Section 9. The amount of ₱300,000.00 representing existing unobligated allotment balance of the allocation for the Electrification for Tinaogan West Lateral Extension and Tinaogan Lateral Line to Teodora Zerna, Barangay Tinaogan, Bindoy, is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Electrification Program from Sitio Candamagan to Habay-Habay, Candabong, Manjuyod.

Section 10. The amount of ₱382,800.00 representing existing unobligated allotment balance of the allocation for the Opening of Barangay Road Going to Sitio Ulayan, Barangay Maloh, Siaton, Negros Oriental, is hereby reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated for the Improvement of Road, Barangay Maloh, Siaton.

Section 11. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
