“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱100,000.00 representing existing unobligated allotment balances of Continuing Appropriations under the General Fund Proper, hereunder specified:

Purchase of Office Furniture and Fixtures.....	₱ 50,000.00
Purchase of Office Equipment.....	50,000.00

is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to fund the following:

Purchase of Motorcycle.....	₱ 70,000.00
Purchase of Office Supplies.....	30,000.00

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
