
"Be it enacted by the Sangguniang Panlalawigan that:


Section 1. The amount of ₱170,608.00 representing current savings from item Salaries and Wages - Regular of the General Fund Proper including devolved Hospitals as of August 7, 2015 is hereby appropriated for the Operation of the Provincial Agriculture and Fishery Council of the Office of the Provincial Agriculturist.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
