“RESOLVES, To approve Addendum No. 44 of the Annual Investment Program for Calendar Year 2015, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 35
(Series of 2015)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱75,000.00 representing unobligated allotment balance of the allocation for item Operation, Maintenance and Promotional Activities of the Tourism Unit with Contract of Services intended for Gasoline, Oil and Lubricants Expenses, is hereby appropriated for the Purchase and Installation of one (1) unit Airconditioner Split-Type, Floor Mounted, 3 Tonner for the Provincial Tourism Unit.


