(Series of 2015)


“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Food Supplies Expenses under the current Regular budget of the Bindoy District Hospital in the amount of ₱40,000.00, to be taken from item Electricity Expenses of same hospital.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2015.
