Espinosa, former Community Development Assistant II of the Environment and Natural Resources Division, Governor's Office.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
