“RESOLVES, To approve Addendum No. 5 of the Annual Investment Program for Calendar Year 2016, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 5
(Series of 2016)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱3,000,000.00 representing existing unappropriated surplus of the General Fund for Calendar Year 2015 is hereby appropriated to cover Job Order Services under the Governor’s Office for the period from July 1 to December 31, 2016, subject to the provisions of Section 26.A of Sangguniang Panlalawigan Resolution No. 612, current series.



Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
