“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱5,000,000.00 representing appropriation balance of the allocation for Support to NIR 16 Regional Offices under the current budget is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the purchase of various hospital and dental equipment for use at the Negros Oriental Provincial Hospital, hereunder specified:

Four (4) Patient Monitors for ICU.....	₱ 2,000,000.00
Two (2) Incubators.....	1,700,000.00


One (1) Defibrillator.....	₱ 600,000.00
