Cual, Officer-In-Charge of the Provincial Accountant's Office, for augmentation of funds in the amount of ₱70,000.00 for item Office Supplies Expenses under the current budget of the Provincial Accountant's Office, to be taken from other MOOE items of same budget;

"On motion of Honorable Member Rommel L. Erames, seconded by Honorable Member Nilo D. Sayson, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 36
(Series of 2016)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Office Supplies Expenses under the current budget of the Provincial Accountant's Office in the amount of ₱70,000.00, to be taken from other MOOE items of same budget, to wit:


Gasoline, Oil and Lubricants Expenses.....	₱40,000.00
Representation Expenses-Reimbursable.....	30,000.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2016.
