Section 1. The amount of ₱255,564.00 is hereby appropriated from the surplus of the Mabinay Medicare Hospital Income for Calendar Year 2015 to cover Payment of Services of eight (8) Staff Nurses and one (1) Medical Technologist for the months of November and December, 2016.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
