“On motion of Honorable Member Jessica Jane J. Villanueva, seconded by Honorable Member Georgita F. Martinez and Honorable Member Ma. Rosario F. Ocay, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 46  
(Series of 2017)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Acting Governor is hereby authorized to augment the appropriation for item Training Expenses under the current budget of the Office of the Provincial Treasurer in the amount of ₱250,000.00, to be taken from the following items:

Other Financial Charges -- Documentary	
Stamps.....	₱50,000.00
Fuel, Oil and Lubricants Expenses.....	200,000.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2017.
