"Whereas, presented for consideration before the August Body was the letter of the OIC-Provincial Administrator dated November 14, 2017, transmitting Resolution No. 41, current series, of the Local Finance Committee, this province, anent the request of Engr. Vivian G. Solomon, OIC-Provincial Engineer for augmentation of funds in the amount of ₱500,000.00, to be taken from item Electricity Expenses under the current budget of the Office of the Provincial Engineer for other MOOE items of same budget;

"Funds having been certified as available by the OIC-Provincial Accountant per her certification dated October 19, 2017;

"On motion of Honorable Member Rommel L. Erames, seconded by Honorable Member Nilo D. Sayson, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 55  
(Series of 2017)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Acting Governor is hereby authorized to augment the appropriation for MOOE items under the current budget of the Office of the Provincial Engineer, to be taken from item Electricity Expenses of same office, viz:

Traveling Expenses - Local	₱ 300,000.00
Training Expenses	200,000.00


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the item Electricity Expenses for Calendar Year 2017.
