"On motion of Honorable Member Edmund F. Dy, seconded by Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 56  
(Series of 2017)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:



Section 1. The Honorable Acting Governor is hereby authorized to augment the appropriation for item Training Expenses under the current budget of the Office of the Provincial Prosecutor, in the amount of ₱50,000.00, to be taken from item Repairs & Maintenance - Transportation Equipment of same office.



Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2017.
