"On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Nilo D. Sayson, the Sangguniang Panlalawigan

"RESOLVES, To approve Addendum No. 6 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 7
(Series of 2017)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,083,349.71 is hereby appropriated from the Surplus of the General Fund for Calendar Year 2016 to fund the following:

- Prizes for Reinforcing the Right Development of Children in Schools and Communities (RRDCSC-GPAK) Program..... ₱400,000.00
- Provincial Counterpart in the Conduct of the General Revision:
- Municipality of Bindoy..... ₱ 361,943.70
Municipality of La Libertad..... 321,406.01

Section 2. The amount of ₱2,000,000.00 is hereby appropriated from the Surplus of the General Fund for Calendar Year 2016 as Provincial Counterpart Contribution to the Surety Fund Equivalent to the Total Amount Invested by the Cooperatives.


Section 3. The amount of ₱2,750,000.00 is hereby appropriated from the Surplus of the General Fund for Calendar Year 2016 for the Grant of Gratuity Pay to Job Orders and Contract of Service Workers in Government as mandated by Administrative Order No. 02 dated January 31, 2017 at ₱2,000.00 each.

Section 4. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
